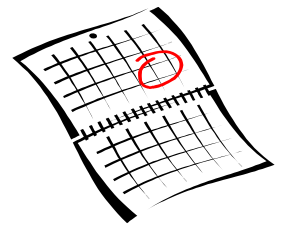
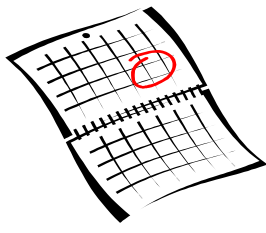

Charles D. Crowe is the Director of the Procurement and Contracts Division for the Department of Energy, Oak Ridge Operations Office. He began his government career in 1975 as an Industrial Relations Specialist at ORO following several years as in the private sector working in academia and as a contractor. In 1980, Charles moved to the Procurement and Contracts Division at ORO as a contract specialist, and was promoted to Chief of the Contract Management Branch in 1987. When emphasis began to focus on environmental clean up, the Division was reorganized, and Charles became the Chief of the Environmental Acquisitions Branch with responsibility for all ORO environmental restoration and waste management contracts. He was selected as Director of the Procurement and Contracts Division in October 1999, and currently has responsibility for ORO procurement, contracts, personal property, and real estate.
