Judy Wilson is the Director of the Procurement and Contracts Division, U.S. Department of Energy's Oak Ridge Office.

She is responsible for overseeing, administering, and support of over \$3 billion in procurement and financial assistance awards and \$4 billion in federal and contractor personal property at the Oak Ridge DOE and other offices across the

Department's complex. She also manages real estate activities on the Oak Ridge Reservation and oversees the Oak Ridge Office Small Business Program. The ORO Procurement and Contracts Division has a staff of 40 Federal employees.

With over 30 years of government service, Wilson began her federal career in 1975 working with the Department of Energy's Training Center and subsequently with Office of Scientific and Technical Information in Oak Ridge. She joined the ORO Procurement and Contracts Division in 1994 where she worked as a Contract Specialist and Contracting Officer in the Environmental Acquisitions Branch and the Acquisition Services Branch. In 2004, she was promoted to Branch Chief of the Environmental Acquisitions Branch and has served in that capacity until her current appointment as Director.

A native Oak Ridger, Wilson earned a Bachelors Degree in Business Administration from the University of Tennessee and a Masters in Business Administration from Bristol University. She serves as a current member of the East Tennessee Chapter of the National Contract Management Association.

Judy, her husband, and sons live in Oak Ridge.
